## **Significant Events**

Harmsco, we may need 3 filters. Patrick is still waiting on Jack and TCEQ for that answer.

Currently we have 2 at 60 gallons/min and one at 90 gallons/min

We can use exiting filters as a pre-filtering (less expensive)

Nancy asked how long do the filters last and Patrick seems to think 6 months.

Collins asked the cost of replacing them every 6 months, 705.00/piece x 2 but we may need three. Need 90 day supply on hand.

Patrick will get back to us on the cost of the current filters and is waiting on an answer from TCEQ about how many filters are needed (2 or 3)

315 gallons per minute are needed.

# **Grounds Maintenance**

Jay found someone who could cut grass at a much cheaper cost of \$200.00. Discussion ensued about needing liability insurance.

Motion made by Jeff and seconded by Nance to let local guy perform ground maintenance for \$200 and it was approved by all.
